# **WORK SESSION**

The Future of Richmond Community Schools: Dr. Bourff stated that formulating discussions that have taken place at previous meetings and incorporating that information into the strategic plan will assist in providing forward momentum to realize the mission and vision of Richmond Community Schools. There was discussion regarding defining the term "joy of learning," technology, pathways, problem based and project based curriculum, and other topics. Dr. Bourff will meet with the new Richmond Education Association leadership to create a draft plan for next year to guide staff.

#### REPORTS DISCUSSION TOPICS

Qualified Entity Purchase Agreement—Indiana Bond Bank and RCS: Bob Coddington reported that the Pension Bond refinancing will save RCS \$62,527.51 every six months on the Pension Bond payment.

#### **FOLLOW UP-OLD BUSINESS**

- •The K. C. STEMM Academy has provided addresses, but not individual data, for their students. Postcards with information regarding Richmond Community Schools have been sent to the addresses provided. There was discussion regarding having special orientations and open houses for all new students and their parents. Dr. Parker stated that a consultant has been assigned by the Department of Education to assist with the closing of the STEMM Academy and that they will host a school choice fair later this summer.
- •Ron Maze gave an update on the Richmond High School, Hibberd, Dennis, and Charles projects. A discussion followed on student safety, increased usage of the athletic field, and other topics. All projects are on schedule to be completed by August 2, 2013.
- •Dr. Bourff congratulated the 2013 Richmond High School graduates, and specifically Henry Dickman for his outstanding graduation speech. The end of year activities and all student accomplishments during the year were celebrated.
- •There are over 200 students enrolled in the Richmond Community Schools summer school program. Stephanie Quinn and Jennifer O'Brien are the administrators for summer school. The Third Grade Academy has 102 students enrolled.
