Transcript/Records Requests Information

A period of 3 working days is required to process all requests

Transcripts: Due to privacy laws, the only individual that can request transcripts is the student/former student. In order to disclose records to a third party, a signed release must be produced.

Transcripts include the classes and grades of all grades of all high school courses, graduation or withdrawal date, class rank, and GPA. Information needed to request a transcript includes: current full name and maiden name (if applicable) or name of student at the time of graduation, withdrawal or transfer, current address and phone number, date of birth, graduation year or the year the student would have graduated if the student withdrew. An official transcript will be sent directly to any employers or to a college or university; transcripts sent directly to a student will be unofficial. When requesting, please specify if the SAT or ACT scores are needed in addition to the transcript. High school transcripts may be requested in person, by phone, or fax. Please complete the attached form and complete when requesting by person or fax.

Records: Due to privacy laws, the only individual that can request these records is the student/former student. In order to disclose records to a third party, a signed release must be produced. Records include proof of attendance or enrollment, proof of graduation, SAT or ACT scores, and immunizations. (Immunization records are not always able to be located in older files, but a search will be done.)

Information needed to request records is the same as for transcripts.

Special Education records can be requested from the Special Services Department at 973-3496.
